The Advisory Committee's decision will be based on the following criteria:

### • *Distinction in Nominee's Field*

Such attainment may be evidenced by achievement or advancement in career, earned degrees or professional training, professional recognition and/or outstanding contributions to the field of endeavor.

### • *Service in the Community*

The nominee shall have demonstrated a record of community participation: public, private, civic, fraternal, religious, etc.

### • *Attendance at 2012 May Graduation and Award Reception*

Must be able to attend and speak at graduation (Friday, May 18, 2012) and award reception.
